## Southeastern Donates \$50,000 for VSU Financial Trading Center Center to Be Named After the Credit Union

As the primary donor to the project, the Center will be officially known as the Southeastern Federal Credit Union Financial Trading Center.

The Financial Trading Center is a state-of-the-art facility that will provide hands on trading experience to business

administration students allowing them to purchase and sell stocks, commodities, metals, currencies, and energy. It is one of the few located in the southern region of the United States and is the only Financial Trading Center in the state that allows students to use real money for trading.

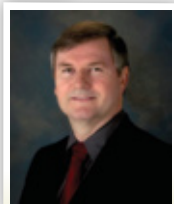
*Please note: This year's annual meeting will be a formal business meeting only. All giveaways and food will be provided during Membership Appreciation Day.*

This year, the Nominating Committee has submitted the names of H. Michael Beverly and John Leonard to fill the two vacancies on the Board of Directors.

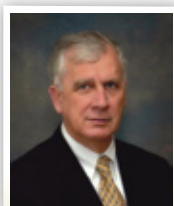
### H. Michael Beverly
